Thank you for your interest in hosting the WEA Outdoor Leadership Experience(OLE), Outdoor Leadership Training Course (OLTC) and/or Certified Outdoor Leader (COL) programs! The WEA has a series of requirements in place for the approval of OLE, OLTC and COL Hosts, instructors, and individual courses. All applicants must be current Organizational Members of the WEA. Involvement with the WEA Accreditation program is not a prerequisite for operating as a WEA OLE, OLTC or COL Host.

Please note: The OLE and OLTC are a "<u>certification of completion</u>" program only — NOT a "certification" program. The COL is a program that leads successful students toward "certification" by meeting credentialing requirements — certification is not guaranteed by participation in the program.

To apply for WEA OLE, OLTC and/or COL Host status please complete the following questions and submit to the WEA National Office as instructed below.

The COE is not required to be present during course field time for the Outdoor Leadership Training Course. The COE is required to be present for the minimum course field time for the Certified Outdoor Leader program.

After the WEA National Office reviews the proposal, the applicant will be notified by the WEA National Office of its status, including any requests for clarification or omission of information. If the organization is approved as a WEA OLE, OLTC and/or COL Host, a letter will be issued to the organization with notification of this status. Approved WEA Credentialing Program Hosts must sign and return the WEA Organizational Member Credentialing Programs Agreement prior to offering any programs. In addition, all approved WEA Host organizations must submit the required pre- and post-course paperwork in accordance with the WEA guidelines. The WEA reserves the right to revoke the Host status at any time.
